LOTTERY REPORT

The year 2022 was again a year of challenges but we were able to do some fund raising.

We did have some raffles and lotteries, realizing a profit of \$2,403.50 combined. 50/50 raffles were held at the monthly meetings, and also at the garage sale and Open House in July making a profit of \$919.50.

We are still searching for a source to sell Nevada tickets. This makes a great void in our ability to raise funds. The prospective outlet we were working with has backed out, so we are again searching for another outlet. This is a great money maker.

The Super Draw 100 Lottery continues to be successful, we were able to hold our Elimination Draw in August, with the theme Having Fun. This event was held taking as many precautions as we could to make it safe. The evening consisted of dinner, entertainment, silent auction and the draws. The Elimination Draw realized a profit of \$1,484.00 and the Silent Auction \$601.00, for a total of \$2,085.00.

The decreased revenue received through the lotteries has not allowed us to cover as many expenses as in previous years, but did pay for some. A detailed Financial Statement giving full details of receipts and expenditures is included below.

The support and cooperation received from our members and the community is appreciated.
